The fees listed in the column on the right hand side mark the fees per month based on one school year (01.08. bis 31.07.). The fees are due to the 5th of each month, also during vacation time. In case of authorized automatic direct debit the date to which the fees are due to is shifted to the 15th of each month. Forms are available at the secretariat.

The enrolment fee is due to the date of conclusion of contract. The enrolment fee is composed of the following amounts:

- Administration fee: 160,- €
- Prorated contribution to gymnasium: 100,- €

The fees marked with \* can be claimed with 30 % as special expenses in the legal guardian's income tax statement

In addition to the regular school fees, costs for consumption items, copies, transport costs, as well as for learning aid, can be brought to account by invoicing latest by the end of the school year. These expenses are part of the school - respectively hort contract

Within the first eight weeks of the following legal year you will receive a written statement of all your payments on account during the preceding legal year. Taking your income situation into account, your tax office decides concerning the crediting of lunch and hort expenses. Under certain preconditions, the Department for Social Work of the state capital Wiesbaden allows subsidy payments for extracurricular activities in the primary school sector (lunch and hort).
